In accordance with the Illinois EPA Environmental Justice Policy, the Office of Environmental Justice wants to provide you with information about a potential action. The Illinois EPA is sending this letter to notify you of an application received by the Bureau of Water (BOW).

The Illinois EPA has received an application for a renewal of National Pollutant Discharge Elimination System (NPDES) Permit IL0047562 for Village of Park Forest located at 75 Park St in Park Forest. The applicant is engaged in treating domestic wastewater for the Village of Lake Forest. The length of the Permit is approximately 5 years. NPDES is a federal program for regulating discharges to a surface water.

The application is currently under review by the BOW. Once ready for review, the Illinois EPA will post a public notice/fact sheet and draft permit on its website (https://epa.illinois.gov/public-notices/npdes-individual-notices.html) and will accept comments during the public notice period. The procedures for public participation in the Water Pollution Control Permit Program can be found at 35 III Adm. Code Part 309.
